

SECTION 00020 INVITATION FOR BIDS DIVISION "B"

The Elloree Water System will receive Sealed Bids for the **Water System Rehabilitation Project, Division "B"**, until 2:00 PM on July 23, 2024 at the Elloree Water System at 2623 E. Cleveland St., Elloree, SC 29047, at which time and place all Bids will be publicly opened and read aloud.

Base Bid: Painting and refurbishment of the Food Lion 500,000-Gallon elevated storage tank. The project includes a full surface preparation and painting of the interior and exterior surfaces of the elevated tank with an engineered coating system. Surface preparation will include media blasting of all existing coatings down to bare metal. Project also includes an electrical grounding system for the Food Lion tank.

Copies of the Contract Documents may be obtained by depositing **\$120** with the Engineer for each set of documents so obtained. The deposit is refundable to responsive bona fide bidders only. All Prime Bidders must obtain a set of Documents.

This project is being funded by a grant from the South Carolina Rural Infrastructure Authority (RIA). Bidders must be aware of and must comply with all applicable state and federal requirements identified in the bid documents. The low bidder will be required to complete all required documentation and submit to the engineer within ten (10) days of the bid opening. The RIA must review the information and approve the contractor prior to issuance of a Notice to Proceed. Reference is made to the information included in Section 00818 - Federal Supplementary Conditions.

No bid shall be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law and has a classification of General Contractor-Public Utilities and a subclassification of Water and Sewer Lines with the appropriate License Group Limitation for the Bid amount. No bidder may withdraw his Bid within 90 consecutive days after the actual date of opening.

A certified check or bank draft payable to the order of the OWNER, negotiable U. S. Government Bonds (at par value), or a satisfactory Bid Bond executed by the Bidder and an acceptable Surety in an amount equal to five percent (5%) of the total Bid shall be submitted with each Bid.

Attention is called to the fact that not less than the minimum salaries and wages as set forth in the Contract Documents must be paid on this project as applicable. The Contractor shall ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, or national origin.

OWNER reserves the right to reject any and/or all Bids or to waive any informality in the Bidding. Bids may be held by the OWNER for a period not to exceed ninety (90) days from the date of the opening of Bids for the purpose of reviewing the Bids and investigating the qualifications of Bidders, prior to awarding of the Contract.
